Terpenoid Analysis

Terpene analysis utilizing gas chromatographyflame ionization detection (GC-FID). Terpenes are the aromatic compounds that endow cannabis with their unique scent and effect. Following are the primary terpenes detected.

Fenchol

A monoterpenoid alcohol with a fragrance that can be described as dry, woody, earthy, piney with a hint of sweet and citrus. It is chiefly responsible for the distinct odor of basil. Found in fennel, basil, eucalyptus, lime, and St. John's wort.



Linalool

A monoterpenoid alcohol with a fragrance that can be described as spicy, waxy, citrus and floral. It is commonly used as an insecticide against cockroaches, flies, fleas and other insects. Found in bail, lavender, cinnamon, hops, mugwort, goldenrods...etc.



Terpineol

A monoterpenoid alcohol with a fragrance that can be described as fresh, floral, piney, woody with a hint of lime. The most common isomer is α -Terpineol. Found in melaleuca, pine, bitter orange, skullcap, tea plant...etc.
